Land Management

Discussion Items from land management.

Electric Metering: Larry Perry. Who will handle figuring out bill? There will be a task force to handle bill.

Pesticide. Larry Perry made a motion, Blake White seconded, to purchase a case of pesticide at an approximate cost of \$500. Motion carried.

LoneStar 17

Larry Perry talked about LoneStar 17. The dates for LoneStar 18 will not be changed as there was no interest in moving the run. We tried two meals a day, a brunch and dinner, but we will revert to three meals a day for future runs. We made approximately \$5,900 from the run. Distribution of the money is 1/3 into savings, 1/3 into general funds and 1/3 for improvements.

Discussion: Hal asked why the division, that in the past it was always just given to the general fund. Ron Denning, can we use some of the money for seed money for LoneStar 18. Jim S. said it has normally been the decision of the Run Coordinator. Stan Morris said he agreed with the allocation. Nothing is being allocated to any specific project.

John Szewczyk made a motion to accept the distribution recommended by Larry Perry. Peter Reid seconded the motion. Jim S. called the question. Motion carried.

Larry suggested a possible retreat in the fall with TCC officers and officers from the various member clubs. We also need to develop a long-term plan for TCC. Meeting would be held after the Quarterly meeting. Meeting date is October 29, 2005. A letter or e-mail will be sent to clubs to invite them to the meeting.

John Swezczyk mentioned some people feel their dues cover maintenance.
